

**APPLICATION FOR MEMBERSHIP AND ELECTRIC SERVICE
GRAND ELECTRIC COOPERATIVE, INC.
BISON, SOUTH DAKOTA**

The undersigned (hereinafter called the "Applicant") hereby applies for membership and agrees to purchase electric energy from Grand Electric Cooperative, Inc. (hereinafter called the "Cooperative") upon the following terms and conditions:

1. The Applicant will, when electric energy becomes available, purchase from the Cooperative all electric energy used on the premises and will pay therefore monthly at rates to be determined from time to time in accordance with the Bylaws of the Cooperative, it being understood that all amounts paid by the Applicant in excess of operating costs and expenses of the Cooperative properly chargeable against the furnishing of such electric energy are furnished by him/her as capital; provided, however, that the Cooperative may limit the amount of electric energy to be furnished to any one member.
2. The Applicant will grant to the Cooperative, a right-of-way easement to construct, reconstruct, operate and maintain an electric line or system on and /or under the land, under and/or upon all streets, roads or highways abutting said land.
3. The Applicant will cause his premises to be wired in accordance with the rules and regulations of the South Dakota Electrical Commission.
4. The Applicant will comply with and be bound by the provisions of the Articles of Incorporation and Bylaws of the Cooperative, and all amendments thereto, and such rules and regulations as may, from time to time, be adopted by the governing body of the Cooperative.
5. The Applicant assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law, his/her private property is exempt from execution for any such debts or liabilities.
6. I request and authorize the Cooperative's board of directors to subscribe to COOPERATIVE CONNECTIONS on my behalf and authorize the subscription price thereof to be deducted from any funds accruing in my favor, so as to reduce such funds in the same manner as would any other expense of the Cooperative.

The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative; and, the agreement for electric service shall continue in force from the date service is made available by the Cooperative to the Applicant, until canceled with at least 30 days written notice given by either party to the other.

Any separate contracts that the Applicant may enter with the Company shall take precedence over the policies and bylaws if inconsistent with the same.
